- 1. Breeder warrants this puppy is in good health on day of sale;
 - i. s/he has been examined by breeder's veterinarian (Dr. Zuniga), and is up to date on vaccinations and deworming at time of sale (copy of record to be transferred to owner).
 - ii. Owner agrees to have puppy examined by their own veterinarian within 72 hours of purchase date. If, at this time, puppy is found to be in ill health, owner may request a replacement puppy (from current litter if available, or may wait until next future litter); may choose to keep the puppy with a thirty percent (30%) refund of

purchase price; or may return the puppy to breeder (at owner's expense) for a full refund. Owner must provide veterinarian- signed copy of diagnosis.

- a. This section is void if owner is negligent or abusive;
- b. if puppy is involved in an accident of any sort (including injury by owner's other animals [domestic or wild], transporting, etc) and sustains injury;
- c. if owner exposes puppy to situations whereby it contracts a vaccinepreventable disease;
- d. canine-epileptic disorders and base narrow canines are not covered.
- Sire and dam have been genetically screened to rule out probability of transferring genetically caused diseases to offspring (copies of health certificates available upon request).
- iv. Breeder guarantees puppy(ies) to be genetically sound. If puppy is found to have a genetically inherited disease by its second (2nd) birthday, breeder will refund half (50%) of purchase price or replace puppy with one from upcoming litter (this decision is breeder's prerogative). Owner must provide veterinarian- signed copy of diagnosis.
- 2. Owner agrees to maintain puppy for the duration of its lifetime in humane, sanitary, and suitable conditions, including, but not limited to:
 - i. Providing routine and emergency medical care;
 - ii. Feeding quality food and providing regular exercise;
 - iii. Allowing dog to live in the house and not;
 - a. Isolated in a garage, barn, outdoor kennel, etc.
 - iv. Providing regular human companionship and appropriate dog training and socialization.
- 3. Owner agrees to sterilize puppy between six and nine (6-9) months of age. This contract does not convey breeding rights to owner.
 - i. Breech of this section mandates a five thousand dollar (\$5,000) fine to breeder;
 - ii. and voids breeder's obligations under health section of this contract (section 1).
- 4. If at any future date owner decides to relinquish puppy, the following steps must be taken:
 - i. Attempt to find comparable and suitable home for the dog;
 - a. If this occurs, breeder must be notified in writing of transfer of ownership, with new owner's complete contact information.
 - b. New owner must abide by terms of this contract (signed copy must be forwarded to breeder; excepting portion of financial renumeration to breeder)
 - ii. If no suitable home can be found, puppy must be returned to breeder at owner's expense within fourteen (14) days;

- iii. Under no circumstance shall puppy be transferred to a shelter, pet shop or business, etc.
- 5. Breeder strives to produce healthy, even-tempered animals and pair them with the best home possible. However, biology and puppy's future home also play pivotal roles in eventual personality, health, and overall characteristics of dog. Thus, breeder does not guarantee:
 - i. Coat: color, hypo-allergenicity, markings, and fur type;
 - ii. Temperament: personality traits, socialization, compatibility with owner's lifestyle;
 - iii. Health: diseases in the animal which could have been prevented with quality care, diet, and exercise.
- 6. If any legal actions are required based upon this contract, they will take place under the jurisdiction of Anaconda- Deer Lodge County, Montana, USA.
- 7.
